DIRECTIONS TO HOTEL:

From North follow I-185 to exit 8 turn right onto Airport Thruway, turn left at first red light onto Sidney Simons Blvd, hotel is on the left.

From South follow I-185 to exit 8 turn left onto Airport Thruway, turn left at the first red light onto Simons Blvd, hotel is on the left.

From West follow Hwy 80 to I-185 south, follow I-185 to exit 8 turn right onto Airport Thruway, turn left at first red light onto Sidney Simons Blvd, hotel is on the left

From East follow Hwy 80 to I-185 south, follow I-185 to exit 8 turn left onto Airport Thruway, turn left at the first red light onto Sidney Simons Blvd, hotel is on the left.

CONFERENCE ROOM RATE:

Single through Quad will be **\$94.00** per night (**rate includes tax**).

CONFERENCE REGISTRATION FEE:
